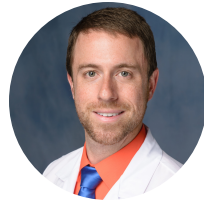


Nicholas Dorsey, MD

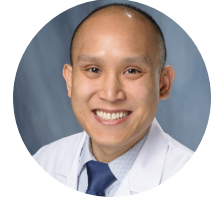

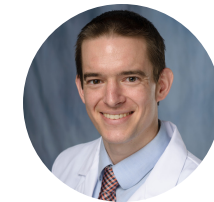

CLINICAL SERVICES

University of Florida Health Physicians, or UFHP, is responsible for managing the clinical component of the University of Florida College of Medicine faculty practice plan. UF Health Family Medicine includes eight clinical locations throughout the Gainesville area. Each clinic has a medical director and an ACU manager who oversees the day-to-day operations of the clinic. In total, we have around **60 physicians** throughout each of our **eight clinics**.

We have a large, unique and diverse patient population that we can serve beyond our core clinics. Our physicians work closely with patients who visit the **Equal Access Center**, and the **Mobile Outreach Clinic** to give them the high-quality care they deserve. The department also co-hosts the **UF Health Primary Care After Hours** clinic, along with the UF Department of Medicine's Division of General Internal Medicine.

This year, CHFM providers had over **170,000 patient encounters**.

This past fiscal year, Richard and Syble Eads established the Braddock Endowment for Underserved Patients, which gives donors the opportunity to address the health care needs of the east Gainesville community. This fund helps eliminate financial barriers to care by providing patients with low-cost prescription vouchers and free public transportation passes. CHFM will continue to work closely with community partners to help improve the quality of care and resources available.

UF Health Wound Care and Hyperbaric Center

The UF Health Wound Care and Hyperbaric Center's modern facility includes four outpatient wound treatment rooms and three monoplace hyperbaric oxygen chambers. Most of the wounds treated are chronic and include diabetic ulcers of the lower extremity, venous leg ulcers, pressure ulcers, arterial ulcers, non-healing surgical injuries, and other wounds. Services include ankle-brachial indices, transcutaneous oxygen testing, debridement, biopsies, wound cultures, dressings to promote moist wound healing, compression wraps, negative pressure wound therapy, total contact casting, advanced tissue therapies, and Xpansion skin grafting.

In the outpatient setting, hyperbaric oxygen therapy is most commonly used to treat delayed radiation injury; diabetic foot ulcers with osteomyelitis or gangrene; chronic and refractory osteomyelitis; compromised skin grafts and flaps; and necrotizing soft tissue infections. The center focuses on a case management model and closely monitors patient outcomes. As a result, the UF Health Wound Care and Hyperbaric Center was presented with the **Center of Distinction** and **Robert A. Warriner, III Center of Excellence** award by Healogics.

UF Health Primary Care After Hours

Serving as a joint venture between CHFM and the Division of General Internal Medicine, UF Health Primary Care After Hours provides an opportunity for returning patients from the family medicine and internal medicine clinics to access primary care providers after regular business hours.

The clinic is staffed by CHFM physicians and nurses as well as clinical staff from the Department of Orthopaedics and Rehabilitation. Dr. Robert Hatch, professor and director of medical education, serves as the medical director, and Katrina Williams serves as the ACU manager.



The clinic is currently seeing patients Monday–Friday from 6 to 9 p.m.

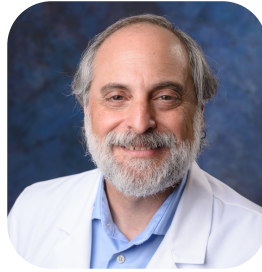

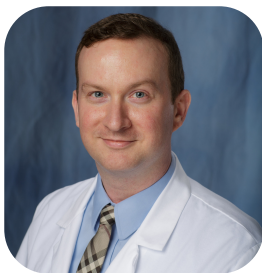

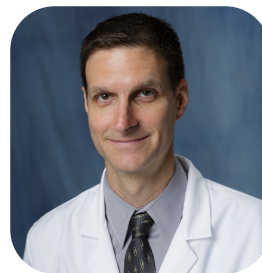

BLMP PROGRAM



ACTIVITIES AND HIGHLIGHTS FOR 2017-2018

During the 2017–2018 academic year, faculty in the Program in Bioethics, Law and Medical Professionalism (BLMP) provided important interactive and up-to-date education for learners at all levels. BLMP faculty taught students throughout all four years of medical school, as well as residents, fellows, graduate and undergraduate students, and health care professionals and learners in the community.

The BLMP faculty deliver the majority of the bioethics education for medical students through the Clinical Ethics, Law, and Professionalism thread. With lectures integrated throughout first- and second-year required courses, small group sessions in the students' Collaborative Learning Groups (CLGs), and other activities, the medical students learn how to identify and analyze ethical issues that arise in patient care and research. Through Professor Bill Allen's required course for first-year medical students in the fall, called Discovery, Research and Health, students also learn about research ethics.

BLMP faculty also taught small groups of students in the Putting Families First: Interdisciplinary Family Health course for students across the UF Health Science Center. This important course reinforces the value of team-based, interprofessional, and interdisciplinary patient care. In Fall 2017, BLMP faculty introduced "Stigma of Illness" as a lecture and CLG topic for second-year medical students. The program faculty also added a new ethics CLG activity for second-year medical students in the fall, during the Pain/Addiction Intensive, on ethical issues in pain and addiction medicine. During Spring 2018, faculty introduced new topics in the medical school curriculum. Dr. Moseley delivered the "Allocation of Scarce Medical Resources" and "The Culture of Medicine" lectures to first-year medical students. Professor Solberg taught "Medical Error, Liability and Apology" to second-year medical students, which was also covered in CLGs. While previously taught in the first year, this topic has been moved to the second year when the medical students learn more about patient safety.

Third-year medical students attended ethics case conferences facilitated by BLMP faculty throughout their clerkship rotations with Family Medicine/Ambulatory Care, Pediatrics, and Psychiatry, and the Family Medicine/Ambulatory Care students also participated in professionalism workshops. Meanwhile, fourth-year medical students also worked with program faculty during ethics case conferences in the Geriatrics Clerkship, as well as in person or online during senior elective courses. These electives are described in the individual faculty highlights below.

Dr. Moseley and Professor Allen expanded their offerings of one of these electives: Financial, Business and Health Systems Aspects of Medicine. For the first time, the senior medical student elective course was delivered fully online and enrollment was opened to also include third-year medical students. The course was well-attended, with 17 students taking the course asynchronously in December 2017, followed by another 13 students during March 2018.

BLMP faculty revamped the ethics curriculum for family medicine residents; with the interns, they facilitated discussions about topics and cases related to professionalism, capacity, confidentiality, informed consent, and end-of-life care. During the next academic year, the curriculum will be further refined and expanded to include the second- and third-year residents in addition to the interns.

Additional faculty teaching highlights:

- **Bill Allen, JD, MDiv** directed the required Law and Ethics thread for UF students pursuing their Doctor of Pharmacy degree. He also led the Discovery, Research and Health required fall course for first-year medical students and the Ethical/Policy Issues in Clinical Research elective spring course for UF graduate students. Advanced Issues in Medical Ethics and Law; History of Medicine; and Religion, Culture and Medicine were all fourth-year medical student electives directed by him as well.
- **Ray Moseley, PhD** presented ethics material to outstanding high school students enrolled in the Student Science Training Program, a seven-week research summer camp hosted by the UF Center for Precollegiate Education and Training. He also hosted monthly ethics workshops for residents in internal medicine, and was invited to serve as the inaugural faculty advisor of the UF College of Medicine's Ethics Society. The group, led by first-year medical students, met several times during Fall 2017 and Spring 2018.
- **Lauren Solberg, JD, MTS** directed a course for graduate students called Law and Ethics of Aging. With colleagues from Texas Christian University and supported by an NSF grant, she created a Coursera course, "TECH MeD: Transdisciplinary Education for Critical Hacks of Medical Devices," about the technical, medical, legal, and ethical issues pertaining to cybersecurity and medical devices.



ETHICS CONSULTATION

BLMP program faculty are the primary source of ethics consultation for UF Health in the hospital as well as outpatient clinics. The bioethicist on call may arrange an individualized or team-based consult to assist with a variety of matters, including addressing decisional capacity concerns; answering questions about informed consent; appointing social worker proxies; executing advance directives; and resolving treatment plan conflicts and end-of-life care issues.

Additional faculty service highlights:

- **Bill Allen, JD, MDiv** served on the planning committee for UF Health's Celebration of National Healthcare Decisions Day. The work group met several times between January and April 2018 to organize countywide events promoting patient empowerment and advance care planning.
- **Ray Moseley, PhD** was the first president and founder of the Florida Bioethics Network. Over the past year, in his capacity as a senior board member, he has worked to boost the communication efforts of the organization, especially through podcasts, newsfeeds, and a revamped FBN website.
- From Summer 2017 through Spring 2018, **Lauren Solberg, JD, MTS** served as president of the College of Medicine Faculty Council in Gainesville. Enshrining the principle of shared governance, the Faculty Council liaises between College of Medicine faculty and UF administration.

RESIDENT EDUCATION PROGRAM



PROGRAM PROFILE

The University of Florida Family Medicine Residency program has made a significant impact on the care provided to patients in Alachua County and northern Florida since **1973**.

Close to **300 residents** have graduated from the family medicine program and have entered the workforce as providers of comprehensive medical care, academics and specialty care in geriatrics, emergency medicine, hospital-based medicine, and sports medicine. The program trains competent, compassionate, ethical, and professional physicians who provide comprehensive care to patients in a continuity of care model. Emphasis is placed on practical and direct patient care-based training in addition to didactic teaching that enhances the learning environment.

The residency program is also committed to supporting each resident in his or her educational endeavors, whether the resident selects a clinical path or moves on to a fellowship, academic medicine or research. New initiatives in the program include an emphasis on high-quality care and patient safety, as well as enhanced educational and research opportunities. The department's mission is to instill in residents the love of lifelong learning by providing the framework and tools to ensure success in the long-term art and practice of medicine.



ACTIVITIES AND HIGHLIGHTS FOR 2017-2018

The Family Medicine Residency program had a great academic year, with over **1,700** total applicants and about **200** from LCME medical schools interested in joining. The department filled a total of **100** interview slots and welcomed nine talented residents to the program. All but one of the graduating residents will be staying in Florida, with five practicing outpatient medicine and two continuing to sports medicine fellowships. During July, the upper-level residents also transitioned to a "min-block" schedule that was created in hopes of allowing residents to be fully engaged in the clinic environment as well as other rotations.

All residents continued working toward improving the number of colon cancer screenings and flu and pneumococcal vaccination rates, as well as promoting tobacco cessation. Second- and third-year residents continued being highly involved in department projects focused on hospital readmission, patient satisfaction, physician well-being, and advance directives.

During December, employees at the Main Street clinic hosted their first annual Holiday Luncheon for patients. It was an opportunity for faculty, residents, staff, and nurses to come together and serve patients a warm meal during the holiday season. The luncheon was highly successful, and they look forward to hosting the celebration once again during the upcoming holiday season.

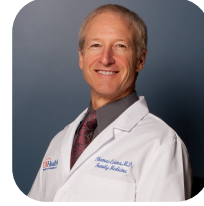

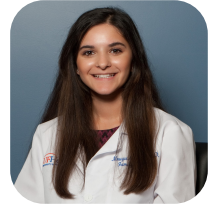

PROGRAM PROFILE

The University of Florida has a history of outstanding athletics and a reputation for excellence in medicine. The UF Primary Care Sports Medicine Fellowship combines elements of both to create an outstanding educational experience for the sports medicine fellow. This ACGME accredited fellowship adds to the Department of Community Health and Family Medicine's long legacy of excellence in education.

Established in **2007**, the program's goal is to produce excellent primary care sports medicine physicians equipped for a lifetime of learning who are prepared for a successful and fulfilling career in primary care sports medicine.

The 12-month curriculum offers abundant exposure to athletic teams and events at the University of Florida and greater North Florida area. Most learning activities take place at the UF Student Health Care Center, UF Orthopedics and Sports Medicine Institute and the University of Florida Athletic Association's training rooms and facilities on the UF campus. The fellowship program accepts up to three fellows each year and is open to applicants trained in family medicine, physical medicine, internal medicine, emergency medicine, rehabilitation, and pediatrics. Applicants residency training must also be from an ACGME-accredited residency program.

Equal Access Clinic Network

A Family of Patient-Centered Free Clinics

The Equal Access Clinic was established by a group of dedicated medical students in **1988**. The clinic opened its doors in **1992** at a local Salvation Army facility and fortunately was later provided with free access to a University of Florida Family Practice Medical Group facility in Gainesville, Florida. Today, **David Feller, MD** serves as faculty adviser, and the organization is one of the largest and most comprehensive student-run free healthcare clinics in the nation.

The Equal Access Clinic network now includes four primary care clinics and a variety of specialty clinics, including women's health, LGBTQ health, mental health, social work, occupational therapy, physical therapy, dental care, and ophthalmology. With support from physicians in CHFM, the clinic has been able to provide high-quality care to over **2,200 patients** during this past fiscal year.

During these visits, the clinic:

- Administered **241** HIV tests
- Screened **1,147** patients for depression and substance use disorders
- Completed **250** dental procedures
- Treated **462** physical therapy patients with an average of 18 patients per night
- Provided **186** free 30-minute therapy sessions with trained psychologists.

As part of their commitment to fostering a welcoming atmosphere, the clinic identified a need to improve our services for Spanish-speaking patients. To remedy this gap, they recently translated all of their patient materials into Spanish and established a designated Spanish night when they have medical students and physicians prepared to provide care in the patients' native language.

At Equal Access, they are constantly searching for ways to improve the patient experience. This year, the clinic collaborated with **Jonathan G. Harrell, MD** at the Mobile Outreach Clinic to establish new services, including an ultrasound clinic and a free prescription service through the Grace Marketplace Pharmacy. The clinic also embarked on their first substantial advertising campaign to increase clinic visibility in the community.

Faculty and staff at Equal Access are proud to have served the Gainesville community for **20 years** and look forward to many more years providing excellent service!

2018-2019 CLINIC GOALS

Ultimately, the clinic wants to be a welcoming place for low-income patients to receive free after-hours care. To achieve this goal, they directed their focus to building a web presence by redesigning their website (equalaccess.med.ufl.edu). The site includes up-to-date information and enables convenient, online appointment scheduling. In less than a year, this tool has allowed the scheduling of **352** appointments, providing a consistent patient volume across all their primary care clinic sites.

The Equal Access Clinic hopes to achieve the following goals during the next fiscal year:

- Increase clinic volume and efficiency by **20%** at all clinic sites.
- Establish a system to constantly evaluate and improve quality across clinic sites.
- Identify top three outstanding patient needs that we can address in 2019.

MOBILE OUTREACH CLINIC



The Mobile Outreach Clinic (MOC) was established in **2010** in response to a growing recognition that many underserved patients in Gainesville were unable to access medical care due numerous socio-economic barriers, especially transportation. The clinic strategically locates itself in Gainesville neighborhoods and common areas with high concentrations of uninsured and under-insured residents, as well as those experiencing substantial health disparities. This past year, MOC joined the Department of Community Health and Family Medicine and have had tremendous support in its transition efforts.

The clinic continuous to be staffed daily by an RN, Ginny Bruzzese, driver, Jorge Herrera, and medical director **Jonathan G. Harrell, MD**, as well as a rotation of paid and volunteer ARNPs, PAs and MDs who provide comprehensive primary care services. The providers rotate on a recurring schedule at the same site in order to ensure high levels of continuity. MOC utilizes the skills of 50 undergraduate volunteer care coordinators who help with day-to-day operations of the bus, as well as off-site phone-based follow-up with patients to help ensure follow-through with care plans. MOC also hosted a robust educational program for undergraduate medical, pharmacy, and physician assistant students of all levels. During their rotations, these students learn how to provide care in settings where social determinants of health play a disproportionately high role in health outcomes. GME is facilitated on the bus through partnerships with the College of Pharmacy PGY-1 residents as well as residents within the departments of family medicine, internal medicine and pediatrics. The clinic also helps provide space and support to the Monday and Wednesday night Equal Access Clinics at Anthem church and Bartley Temple.

This past year was full of exciting accomplishments for MOC and its partners. During the summer, the bus underwent extensive renovations to update and modernize the patient care spaces. MOC also held a community open house at the College of Medicine to show off the new bus, and an impressive contingent of local and state representatives, as well as community partners, gathered to celebrate the renovated bus. In the fall, the clinic was also able to help establish the **GRACE Pharmacy** program, which provides free prescription medication to uninsured patients. Additionally, this past spring, the clinic was able to use grant funding to purchase a portable ultrasound and successfully partnered with the Department of Radiology to offer free ultrasound examinations to patients being served by Alachua County Safe Net clinics. The spring also marked the launch of the **BESTYou Program**, a community based chronic disease self-management program.

Finally, the clinic developed a relatively novel tool for monitoring **social determinants of health (SDOH)** in their perspective patient population. The SDOH dashboard, located within their HOPE database EMR, catalogues the specific social, economic, and educational barriers faced by patients and allows MOC to better target services for these patients as well as monitor progress along these areas over time.

It was a busy year for MOC, with a total of **3,098 patient visits!**

2018-2019 CLINIC GOALS

The Mobile Outreach Clinic hopes to achieve the following goals during the next fiscal year:

- **Education:** Continue to build their social determinants of health curriculum for their 4th-year elective and PA rotation as well as branch out into the 3rd-year clerkships and local/global health equity track.
- **Community Outreach:** Expand the BESTYou program to neighborhoods throughout Gainesville and support partnerships with Eastside community leaders to provide health education. Investigate partnerships with RTS and GFR to facilitate co-location of services.
- **Quality Improvement and Research:** Continue to develop the SDOH dashboard and utilize it to improve patient outcomes. Continue partnerships with College of Pharmacy to improve hypertensive and diabetic care. And further expand LARC services.
- **Long-Term Sustainability:** Continue exploring new grant funding opportunities and work towards establishing an endowment for greater financial stability.

BEHAVIORAL MEDICINE PROGRAM

The behavioral medicine faculty and staff participate in projects and activities involving all significant missions of the department and the UF College of Medicine, including teaching and administrative activities, direct patient care services, consultations, and research/scholarly activities. Regarding educational programs, behavioral medicine faculty undertake the development and implementation of medical, and educational programs for family medicine residents, medical students, community practicing physicians, and academic physicians.

One primary focus of the program is on curricula designed to educate medical trainees in various aspects of the biopsychosocial model of care, including home visits and office-based lifestyle modification (e.g., smoking cessation, healthy exercise patterns). Other areas of particular emphasis include **360-degree evaluation** of resident performance, including physician-patient communication skills and professionalism.

The behavioral medicine program is an integral part of the clinical mission of the department. The faculty and staff of the program provide psychotherapy and evaluation services to patients referred by the physician faculty of the department and by the family medicine residents.

PROGRAM OBJECTIVES

Some behavioral medicine educational activities include:

- Co-leading small groups during the “Essentials of Patient Care” and “Interdisciplinary Family Health” sections of the medical school curriculum.
- Workshops and lectures on behavioral medicine topics during third- and fourth-year clerkships.
- Ten to twelve lectures on human behavior and mental health presented as part of the Residency program didactic sessions for third-year Family Medicine and Ambulatory Care clerkship and fourth-year required Medicine rotation students.
- Behavioral Medicine program faculty consult and precept third- and fourth-year medical students regarding the social agency needs of patients, the assessment of psychological disorders, and the management of family conflict.

QUALITY AND PATIENT SAFETY



2017-2018 OVERVIEW

CHFM continues to evaluate current quality indicators and sets goals to provide the best patient care possible to the Gainesville community. Department-wide quality improvement projects focus on chronic conditions such as diabetes mellitus, and preventive services such as screening for colorectal cancer.

Additionally, the department seeks to improve the process of care and monitor measures such as hospital readmission rates and emergency department utilization. While these initiatives are department-wide, our faculty and staff at each of the clinics are the driving force behind the high quality of care provided.

As a result, all family medicine clinics are recognized by the National Committee for Quality Assurance (NCQA) as level 2 Patient-Centered Medical Homes (PCMH). PCMH recognition on any level requires a significant amount of effort and expertise, with much dedication and coordinated teamwork, to transform clinic processes and practices from one of the traditional doctor-centered medical practices to one that is truly patient-centered.

The family medicine inpatient service and clinics continue to work towards reducing hospital readmission rates. A readmission registry has been created to keep track of patients who were discharged from family medicine practices at UF Health. Weekly readmission rounds, incorporation of nurse health coaches, timely follow-up after emergency department visits, assistance with transportation to clinic visits, and development of a transitions of care clinic are some activities the department has incorporated in hopes of lowering readmission rates.

CHFM also continues to improve select measures associated with the Physician Quality Reporting System (PQRS). The number of patients with diabetes mellitus with a Hgb A1c >9, nephropathy screening in patients with diabetes mellitus, rates of influenza and pneumococcal vaccination, blood pressure control in patients with hypertension, and colorectal cancer screening rates.

The department looks forward to another year of enhancing quality and patient safety.
